### **What are the penalties associated with parking tickets?**

Disabled Only/Permit Required	\$200.00
Where Signs Prohibit	\$25.00

On Sidewalk/Crosswalk	\$25.00

### **How can I pay my parking ticket?**

Online:

Yes, you can pay online at this website. You will need your ticket number in order to be able to pay online.

### **Can I make several payments at once, or make each payment individually?**

Each ticket must be paid in an individual transaction.

### **Is there an additional charge to pay online?**

No, there is no additional charge to pay your ticket online.

### **What if I have a handicap placard but it wasn't displayed at the time of the ticket?**

If you have a handicap placard but it wasn't displayed at the time of the ticket then you may bring the handicap placard issued to you and your identification to the lobby of the Police Department within five (5) calendar days of the ticket to receive a reduction in the fine. The person who is issued the handicap placard must be the person present at the Police Department in order for the fine to be reduced.

**What if I don't agree with my parking ticket?**

If you disagree with your parking ticket you have the right to contest the violation. To appeal a parking ticket, please call the Kissimmee Courthouse-Traffic Division at (407) 742-3566. In order to appeal your citation, you must appear in person to dispute the citation. The address is 2 Courthouse Square, Kissimmee, FL 34741 on the 2nd floor. If you want a translator for your appeal, you must request one at the time you request the appeal process to be started. **You must submit your appeal in person within (10) days from the date the citation was issued. You will not be eligible to appeal after (10) days.**

**What will happen if I do not pay the parking ticket or respond to the parking ticket?**

Failure to pay the parking ticket or request a hearing within ten (10) days will result in a late fee of ten dollars (\$10). Also, the Department of Highway Safety and Motor Vehicles will be notified so you will not be able to register your vehicle again until the ticket is paid.
